My hope is that everyone is allowed to proceed at their own comfort level. Return to buildings that are following strict safety protocols and safely work with students or continue to teach remotely to students who choose to remain remote.

#### **Safety Teams**

# Requesting Remote Work During COVID (this is a repeat of an email I sent)

There are two "High Risk" categories as defined by the CDC that allow members to request remote work.

- High-Risk Employees as defined by <u>CDC quidelines</u>
- High-Risk Individual in the Employee's Household as defined by CDC guidelines (same link as above)

If you fall into either category above, please

read the MOU pages 2 and 3. The HR department will help you with required documentation. If your high risk is being over 65 you don't need documentation. If the Individual in your household is over 65 you need a copy of their driver license or birth certificate, but no doctor's notes.

If you do not fall into the above two categories and you are one of the many OEA members who do not feel safe moving to in-person learning until receiving a vaccination you may still request remote work. However, they are going to give the remote work to members in the High-Risk group first. Tell HR you want to request remote work but you are not in a high risk category.

Everyone also has the option of using sick and personal leave. OSD requests a doctor's note if you will be using more than three sick leave days.

#### **Don't Forget**

- OSPI let everyone whose certificate was due in 2020 push recertification off a year. So there will be more to process in 2021.
- For this year only, you need to time slip Experience Days if you are at year 22 or beyond. To use the electronic timesheet, go to Intranet/Forms/Electronic Time Reporting System

#### **VEBA Advice**

In order to most benefit from retirement, people should not cash in sick leave hours until they get near 1440 saved hours. 1440 is the maximum that can be cashed out at retirement. But turning them in as late as possible means getting the highest hourly rate for the hours since our per diem rates go up each year. Here is a draft of a basic summary of sick leave buy back options:

- Putting them in VEBA helps you avoid paying income tax and they can be spent on current or future medical expenses like medical insurance post retirement or something.
- Cashing them out for money incurs income taxes but is still not a bad idea for those who need it for finances.
- Some also cash out and invest, figuring that they might make more by investing than it will cost to pay the tax.
- but... your VEBA account is also an investment account. Most people do not realize that in their VEBA account they can opt to have their funds invested in a variety of stock or bond options just like



our TRS retirement funds.
•Saving hours to donate to colleagues who find themselves in desperate need is also a nice thing.
